

## EXHIBIT A

(Partial Release of Mortgage Lien by Estate of Edgar Bluford League)

## I.

All those certain pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina near the City of Greenville located along the rear lines of Lot Nos. 99 through 104 of Stratford Forest Subdivision, containing a total of 3.22 acres, being shown and designated on a plat of survey for Carl Dennett Blyth, Sr. by W. R. Williams, Jr. dated September 21, 1981 revised April 8, 1982 recorded in the RMC Office for Greenville County, South Carolina in Plat Book Q-A Page 39 and having, according to said plat, in the aggregate the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint rear corner of Lot No. 104 and Lot No. 110, Stratford Forest Subdivision, which iron pin is located N. 9-55 W. 230.4 feet from a concrete monument on the northern side of Roe Ford Road at the southwestern corner of Lot 110, Stratford Forest Subdivision, and running thence from said point of beginning, S. 80-07 W. 109.3 feet to an iron pin; thence N. 9-49 W. a total of 725.9 feet to an iron pin; thence N. 10-28 W. 278.4 feet to an iron pin; thence N. 9-42 W. 280.1 feet to an iron pin; thence N. 80-51 E. 112.0 feet to an iron pin at the joint rear corner of Lot No. 98 and Lot No. 99 of Stratford Forest Subdivision; thence along the rear line of said Lot 99, S. 9-34 E. 292.9 feet; thence along the rear line of Lot 100, S. 9-51 E. 256.5 feet to an iron pin; thence along the rear line of Lot 101, S. 9-52 E. 200.3 feet to an iron pin; thence along the rear line of Lot 102, S. 9-58 E. 200.5 feet to an iron pin; thence along the rear line of Lot 103, S. 9-45 E. 192.7 feet to an iron pin; thence along the rear line of Lot 104, S. 9-55 E. 141.0 feet to an iron pin, being the point of beginning.

## II.

ALSO all those certain pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina near the City of Travelers Rest on the northeastern side of Foothills Road containing a total of 3.09 acres being shown and designated on a plat of survey for Carl Dennett Blyth, Sr. by W. R. Williams, Jr. dated May 11, 1978 recorded in the RMC Office for Greenville County, South Carolina in Plat Book Q-A, Page 38 and having, according to said plat, in the aggregate the following metes and bounds, to-wit:

BEGINNING at a point in the center of Foothills Road located one-half mile more or less west of the intersection of said Foothills Road with Duncan Chapel Road and running thence with the center line of Foothills Road, N. 39-47 W. 185.6 feet, N. 39-23 W. 800 feet, N. 37-00 W. 100 feet, N. 33-46 W. 500 feet, N. 39-38 W. 100 feet, N. 48-17 W. 100 feet, and N. 52-15 W. 100 feet to an old nail and cap; thence turning and leaving Foothills Road and running N. 52-36 E. 155.6 feet to an old iron pin; thence S. 34-14 E. 2,404.5 feet to a point in the center of Foothills Road, being the point of beginning.
