"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of _____

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, near Simpsonville, South Carolina, known and designated as a 1.10 acre tract as shown on Plat entitled "Property of Hal E. Lowder and Patricia R. Lowder" made by Carolina Surveying Co. dated July 13, 1982, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 9C at page 64, reference being craved hereto to said Plat for exact metes and bounds.
