# MORTGAGE

THIS MORTGAGE is made this 16th day of July, 1982, between the Mortgagor, William L. Ashe, and Ann W. Ashe, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy Eight Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated July 16, 1982, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on August 1, 2012.

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 368 on plat of Devenger Place, Section 15, recorded in Plat Book 8 P at page 26 and having such courses and distances as will appear by reference to said plat.
