MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Anderson, being shown and designated as Lot Nos. 19,20,21,22 and 23 on a Plat of Shady Cove Subdivision on the waters of Lake Hartwell on a plat recorded in Plat Book 55 at Page 288, being the property conveyed to the mortgagor by deed of Robert H. Strange, et.al. dated Nov. 19,1971 and deed of C.P. Stevenson dated August 31, 1977 and recorded in deed books 17B at page 957 and book 180 at page 613.
