WHEREAS, DENNIS W. FOWLER

with interest thereon from said date at the rate of three (3%) per centum per annum, to be paid: monthly.

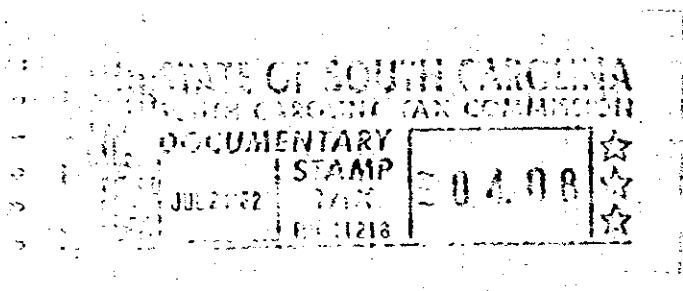

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as a portion of Lot 23 and a portion of Lot 24 on plat entitled "Property of Dennis W. Fowler and Shirley P. Fowler" as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4Z at Page 16.
