MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

H. Charles Parker, Jr. and Norma Kirkland Parker (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto First National Exchange Bank of Virginia, a Virginia corporation, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifty nine Thousand and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 16 on plat of Belle Terre Acres, Section 1, recorded in Plat Book 000 at page 105 and having such courses and distances as will appear by reference to said plat.
