NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Huntington Road, containing 3.65 acres, more or less, being shown on a plat, captioned "Property of Martin Schlein and Edith S. Schlein", prepared by R.W. Dalton, dated July, 1982, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 9-E, Page 8, reference to which is made for a more complete description. Together with the interest of the Mortgagor in the "Sight Easement" on, over, and across the adjoining triangular lot.

Being the same conveyed by Lloyd E. Angell to the Mortgagor by deed dated July 30, 1982, recorded herewith.

This is a second mortgage, junior in rank to the mortgage executed herewith by the Mortgagors to American Federal Savings and Loan Association, equal in rank to the mortgage executed to Lloyd E. Angell herewith. Any other provision notwithstanding, if the Mortgagors shall convey the property described above or any interest therein to any other person (except to themselves) prior to July 30, 1985, the holder or holders of this Mortgage shall have the right to declare the entire unpaid balance upon the promissory note secured herewith immediately due and payable.
