25. Borrower acknowledges receipt of a copy of this Mortgage.

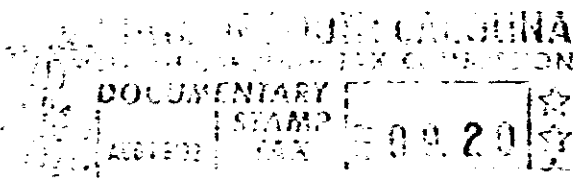
