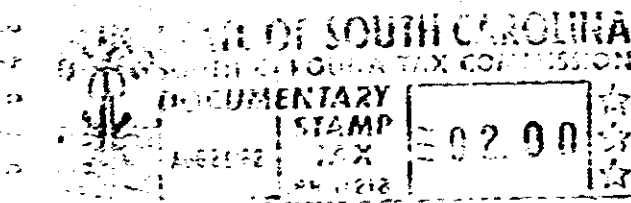
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 19 on Plat of Section 2, Tanglewood, made by Lane & Webb Surveyors, recorded in Plat Book GG, page 57, and having the following metes and bounds, according to said plat:
