MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, GARVIN J. MARR AND CARRIE M. HAWKINS

(hereinafter referred to as Mortgagor) is well and truly indebted unto GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five thousand three hundred ninety-five and no/100-----

----- Dollars (\$ 5,395.00) due and payable upon demand, which shall be at such time as Garvin J. Marr and Carrie M. Hawkins become deceased or cease to own or occupy the premises below described. At such time the principal amount shall be due in full with no interest thereon.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being shown as lot #18 section A on a plat of Sunny Slope recorded in the R.M.C. Office for Greenville County in Plat Book F at page 86, and having the following metes and bounds, to-wit:

BEGINNING at a point on Fletcher Street at the joint front corner of lots 18 and 20 and running thence N. 80-12 W. 150 feet to a point; thence N. 9-48 E. 52 feet to a point; thence S. 80-12 E. 150 feet to a point on Fletcher Street; thence with said street S. 9-48 W. 52 feet to the point of beginning.

DERIVATION: This being the same property conveyed to the Mortgagors herein by virtue of a deed from W. H. Johnson and Lillie B. Johnson recorded in the R.M.C. Office for Greenville County in Deed Book 1130 at Page 861 on August 11, 1980.
