(the "Mortgagor") and UNION HOME LOAN CORPORATION OF SOUTH CAROLINA, a body corporate (the "Mortgagee").

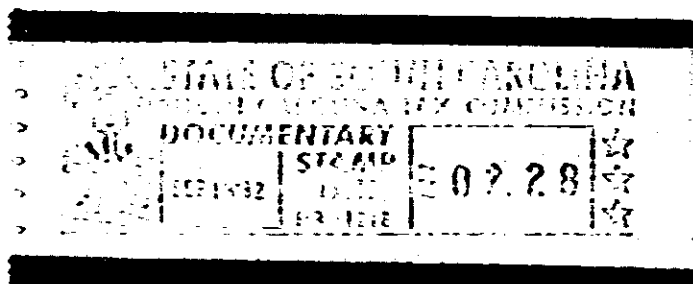
WHEREAS, the Mortgagor is justly indebted unto the Mortgagee in the sum of Five thousand six hundred fifteen & NO/100 Dollars (\$ 5,615.00), (the "Mortgage Debt"), for which amount the Mortgagor has signed and delivered a promissory note (the "Note") of even date herewith payable to the Mortgagee, or order, the final installment thereof being due on September 15, 1988 .

KNOW ALL MEN, that the said mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the condition of the said note, and also in consideration of the further sum ONE DOLLAR, to the said mortgagor in hand well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presence do grant, bargain, sell and release unto the said mortgagee:

ALL that piece, parcel or lot of land, with all improvements thereon or hereafter constructed thereon, situate, lying and being on the northeastern side of Fork Shoals Road in the County of Greenville, State of South Carolina, being designated and shown as Lot No. 4 on Plat of John R. and Bernice L. Julian, prepared by Jones Engineering Service, dated June 24, 1971, recorded in Plat Book 4N at page 31 and being more particularly, according to said plat, to-wit:

BEGINNING at an iron pin on the northeastern side of Fork Shoals Road at the joint front corner of Lots 4 & 5 and running thence along the common line of said lots, N. 69-41 E. 450.7 feet to an iron pin at the joint rear corner of said lots; thence S. 19-09 E. 95 feet to an iron pin at the joint rear corner of Lots 3 & 4; thence along the common line of said lots S. 69-41 W. 450.7 feet to an iron pin at the joint front corner of said lots on the northeastern side of Fork Shoals Road; thence along said road N. 19-09 W. 95 feet to an iron pin, the point of beginning.
