The words "you" and "your" refer to Mortgagee. The words "I," "me" and "my" refer to all Mortgagors indebted on the note secured by this mortgage.

To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville
 All that lot of land situate on the west side of Mayfair Drive, near the city of Greenville, in Greenville County, S.C., being shown as Lot No. 18 of Block D, on plat of Mayfair Estates, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book S, at pages 72 and 73, and having, according to said plat the following notes and bounds, to wit:

Beginning at an iron pin on the west side of Mayfair Drive, joint front corner of lots #17 and #18, Block D, and running thence along the line of lot #17, S. 73-51 W. 202.2 feet to an iron pin; thence S. 4.09 W. 19.9 feet to an iron pin; thence with the line of lot #19, S. 83-23 E. 205.4 feet to an iron pin on the west side of Mayfair Drive; thence with the curve of Mayfair Drive (the chord of which is N. 6-25 W. 99.7 feet) to the beginning corner.

Derivation is as follows: Deed Book 1085, Page 836, From James E. Trotter dated August 22, 1978.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

I will pay all taxes, liens, assessments, obligations, encumbrances and any other charges against the real estate and maintain insurance on the real estate in your favor in a form and amount satisfactory to you. If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

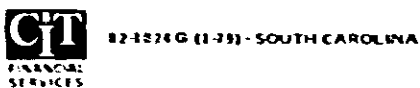
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
