THIS MORTGAGE is made this 30th day of September 1982, between the Mortgagor, Robert R. Heos, Jr. and Cynthia J. Heos American Service Corporation (herein "Borrower"), and the Mortgagee, American Service Corporation, a corporation organized and existing under the laws of the State of South Carolina, whose address is P.O. Box 1268 Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty One Thousand Seven Hundred and no/100ths Dollars, which indebtedness is evidenced by Borrower's note dated September 30, 1982 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2012

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville State of South Carolina:

ALL that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, situate on the eastern side of Gettysburg Court and being shown as Lot No. 182 on a plat of Powderhorn, Section 4, recorded in the Office of the RMC for Greenville County in Plat Book 8-P at Page 22 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Gettysburg Court at the joint front corner of Lot 182 and Lot 181 and running thence N 70-15 E 119.55 feet to an iron pin at or near the center of a Duke Power right of way; thence S 39-05-15 E 62.08 feet to an iron pin; thence S 30-46 W 119.59 feet to an iron pin at the joint rear corner of Lot 182 and Lot 183; thence N 55-45 W 116.4 feet to an iron pin on Gettysburg Court; thence with said Court N 7-15 E 45.4 feet to the point of beginning.

This is the same property conveyed to the Mortgagors by deed of the Mortgagee, dated and recorded of even date herewith.
