



# MORTGAGE

THIS MORTGAGE is made this 10th day of September 1982, between the Mortgagor, Ronald L. Hamby and Donna L. Hamby (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty three thousand nine hundred fifty and 08/100 Dollars, which indebtedness is evidenced by Borrower's note dated September 10, 1982 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 15, 1989;

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being on the southeastern side of Pleasantdale Circle in the County of Greenville, State of South Carolina, being known and designated as property of Mr. and Mrs. Ron Hamby consisting of .607 acres as shown on a plat of Freeland & Associates, Engineers, dated October 11, 1978, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plate Book 6W at Page 57 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Pleasantdale Circle and running thence S.46-37 E. 125 ft. to an iron pin; thence S. 43-23 W. 180 ft. to an iron pin; thence N. 46-37 W. 168.66 ft. to an iron pin; thence N. 57-01 E. 185.22 fot to the point of beginning.

The within conveyance is subject to such restrictions, setback lines, zoning ordinances, utility easements and rights of way, if any, as may affect the described property.

This is the identical property conveyed to the grantors herein by deed of James L. and Ruth M. Leake, Jr. dated October 20, 1978 and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed book 1090 at Page 540 on October 25, 1978.
