MORTGAGE OF REAL ESTATE

R.M.C. WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, RUBY S. MCDONALD

(hereinafter referred to as Mortgagor) is well and truly indebted unto GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two thousand three hundred twenty-three and no/100----- Dollars (\$2,323.00) due and payable upon demand, which shall be at such time as Ruby S. McDonald becomes deceased or ceases to own or occupy the below-described premises. At such time the principal amount shall be due in full with no interest thereon.

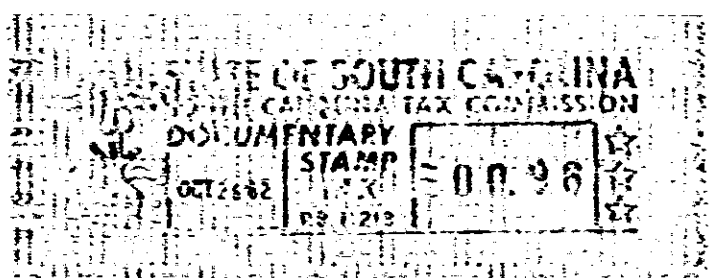
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Dunean Mills Village, and being more particularly described as lot #8, section 2 as shown on a plat entitled "A Subdivision for Dunean Mills Village, Greenville, S.C.", made by Pickell & Pickell, Engineers, Greenville, S.C., June 7, 1948, revised June 15, 1948 and August 7, 1948 and recorded in the R.M.C. Office for Greenville County in Plat Book S at pages 173-177, inclusive. According to said plat the within described property is also known as 46 Duke Street and fronts thereon 69.8 feet.

DERIVATION: This being the same property conveyed to the Mortgagor herein by virtue of a deed from Velma Sue Ross recorded in the R.M.C. Office for Greenville in deed book 1162 at page 142 on February 8, 1982.
