MORTGAGE OF REAL ESTATE

ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, CLYDE S. BAYNE and KEVIN S. BAYNE

(hereinafter referred to as Mortgagor) is well and truly indebted unto BANK OF TRAVELERS REST

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight Thousand and No/100-----
Dollars (\$ 8,000.00) due and payable

In monthly installments of Two Hundred Twenty-Two and 64/100 Dollars (\$222.64) commencing November 25, 1982 and Two Hundred Twenty-Two and 64/100 Dollars (\$222.64) on the 25th day of each and every month thereafter until paid in full.

with interest thereon from date hereof at the rate of Fifteen (15) per centum per annum, to be paid: Monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

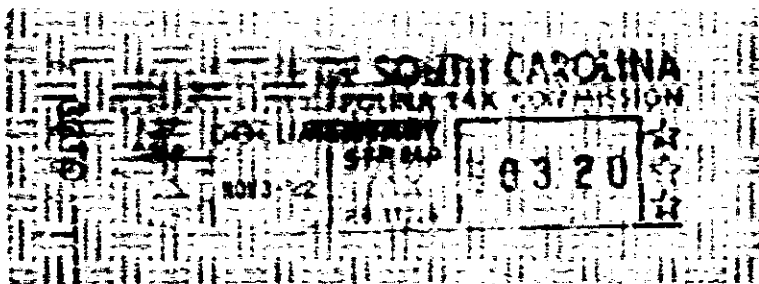
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or tract of land situate, lying and being in Bates Township in the County of Greenville and State of South Carolina, about twelve miles Northwest of Greenville Court House, having the following metes and bounds:

BEGINNING at iron pin NM on road leading to property now or formerly owned by Mrs. Becknell, thence N. 77- $\frac{1}{2}$ W. 4.15 ch. to iron pin NM; thence N. 41 W. 9.30 ch. to iron pin NM; thence S. 44 W. 6.21 ch. to iron pin NM; thence N. 44 W. 8.93 ch. to stone XOM; thence N. 43- $\frac{1}{3}$ E. 9.70 ch. to stone XOM; thence S. 46 E. 22.50 ch. to pin in road; thence 3.42 ch. to beginning corner, and contains fifteen acres.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
