H. Hammett S. 35-04-03 W. 362.73 feet to an iron pin; thence continuing along the Hammett Line S. 35-04-03 W. 49.87 feet to an iron pin; thence continuing along the Hammett Line, S. 35-04-03 W. 47.73 feet to an iron pin; thence N. 62-30 W. 233.0 feet to an iron pin; thence N. 33-59 E. 25.50 feet to an iron pin in or near the center line of a creek and in the rear line of lot no. 155 of River Downs, Section II; thence with the creek as the line the traverse lines of which are: N. 1-45 W. 22.85 feet to a point, N. 55-42 E. 52.2 feet to a point, N. 42-39 E. 65.35 feet to a point, S. 51-25 E. 26.5 feet to a point, N. 29-47 E. 86.0 feet to a point, N. 83-30 E. 71.0 feet to a point, N. 63-50 E. 31.2 feet to a point, N. 63-50 E. 103.7 feet to a point and N. 79-06 E. 117.3 feet to the point of beginning.
