WHEREAS, Bennett R. Skelton

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the eastern side of Rockwood Drive, being shown and designated as Lot No. 1 on plat of Meyers Park Subdivision, Section 1, prepared by C. O. Riddle, Surveyor, dated September, 1976, recorded in the RMC Office for Greenville County in Plat Book 5-P at Page 53 and revised plat dated November 10, 1976, recorded in the RMC Office for Greenville County, SC, in Plat Book 5-P at Page 56 and having, according to said plat, such metes and bounds as are more fully shown thereon.

This being the same property conveyed to Bennett R. Skelton and Alice H. Skelton by deed of Louis Builders, Inc., dated May 1, 1978, recorded in Book 1078 at Page 419 on May 3, 1978. Alice H. Skelton conveyed her interest in said property to Bennett R. Skelton by deed dated January 29, 1981, recorded in Book 1142 at Page 41 on February 3, 1981.
