WHEREAS, Douglas N. Durkee

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

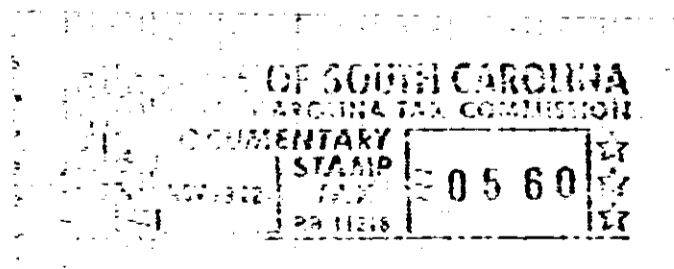
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 94, Winding Way, Peppertree Subdivision, Section 3, as shown on a plat dated December 14, 1972, being recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4X, Page 4, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin located on the southern side of the right-of-way of Winding Way, joint corner of Lots 95 and 94; thence along said right-of-way N 86-29 E 85 feet to an iron pin; thence S 1-41 E 150 feet to an iron pin; thence S 86-18 W 75.4 feet to an iron pin; thence N 5-16 W 150 feet to an iron pin, the point of beginning.

DERIVATION: This being the same property conveyed to Mortgagor by deed of Douglas Dodd Griffeth and Maureen R. Griffeth as recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 1158, Page 913, on December 1, 1981.
