SEND GREETINGS:

WHEREAS, I, ~~we~~ the said Naomi H. Hindman, hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Greenville S. C., hereinafter called Mortgagee, the sum of 6,613.59 plus interest as stated in the note or obligation, being due and payable in 36 equal monthly installments commencing on the 15 day of January, 1983, and on the same date of each successive month thereafter.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, in Butler Township, about two miles southeast of Batesville, on the south side of Circle Road and being a part of the same property conveyed to James R. Hindman and Naomi H. Hindman by deed recorded in the RMC Office for Greenville County in Deed Book 526 at Page 696 and having the following metes and bounds, to-wit:

BEGINNING at an old nail and cap in the center of Circle Road, joint corner of the within described lot and runs thence with the common line of the old and new lots, S.02-00 E. 281.5 feet to an iron pin on the Franklin Smith line; thence with the said line, S.54-19 W. 8.6 feet to an iron pin, joint corner of this lot and that lot being conveyed to Ronnie J. and Margie W. Smith; thence with the common line of the two parcels, N.27-00 W. 256.5 feet to a nail and cap in the said Circle Road; thence with the said road, N.63-00 E. 126.5 feet to the beginning corner, containing 0.35 of one acre, more or less.

THIS being the same property as that conveyed to James R. Hindman and Naomi H. Hindman by deed from Thomas L. Walker and Josie B. Walker recorded in the RMC Office for Greenville County in Deed Book 979 at Page 154 on July 16, 1973. James R. Hindman conveyed his one-half interest to Naomi H. Hindman by deed recorded in said RMC Office in Deed Book 1153 at Page 305 on August 10, 1981.

ALSO: ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, Butler Township, about two miles south from Pelham, lying on the southern side of the Loop Road, and being a part of the same tract of land conveyed to Thomas L. Walker and Josie B. Walker by deed recorded in the RMC Office for Greenville County in Deed Book 696 at Page 526, and having the following metes and bounds, to-wit: *CONTINUED ON ATTACHED SHEET---

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due, and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgagee debt, whether due or not.
- (3) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
