THIS MORTGAGE made and entered into the day and year written on the reverse side hereof by the Borrowers named above, herein called Mortgagors, to LANDMARK FINANCE CORPORATION OF SOUTH CAROLINA herein called Mortgagee, the owner and holder of the Promissory Note referred to below.

WITNESSETH: THAT WHEREAS the Mortgagors are justly indebted to the Mortgagee for money loaned as evidenced by their Promissory Note of even date herewith executed and delivered by the Mortgagors to the Mortgagee in the amount of the Total of Payments stated above, which includes interest and charges as provided in said note.

AND WHEREAS, the Mortgagors desire to secure the payment of said debt and Note, and any renewals or extensions thereof, and the undertakings prescribed in this Mortgage by the conveyance of the premises hereinafter described.

THEREFORE, in consideration of the aforegoing and other good and valuable considerations, Mortgagors bereby give, grant, bargain, sell, assign and convey to Mortgagee, its successors and assigns, the following described real estate, together with all present and future improvements thereon, in South Carolina, County of Greenville.

All that certain piece, parcel or lot of land, situate, lying and being in the state of South Carolina, County of Greenville, Dunkin Township, and containing 1.11 acres, or more or less, according to the plat prepared by Anderson Surveying Associates, Inc. entitled "To be Conveyed to Margaret Harkleroad", dated July 15, 1977, to be recorded in plat book 6G, Page 13, R.M.C. Office for the Greenville County, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin, which iron pin in the Northweastern edge of a dirt road is approximately 370 feet Northeast of the intersection of a 40 foot dirt road and Holliday DAM Road, and running thence N. 11.00 W., 160 feet to an iron pin; thence turning and running N.68-43 E., 300 feet to an iron pin; thence turning and runing S.5-07E., 118.65 feet to an iron pin in the Northweastern edge of the aforesaid dirt road; thence along said dirt-road, S.34-08 W., 135.6 feet to an iron pin; thence continuing along said dirt road, S.79-CO W., 136.8 feet to an iron pin, the point og beginning.

Being a portion of the property conveyed to William A. Henry be deed of R.H. Smith, recorded January 18, 1964, in deed book 740, Page 201, R.H.C. Office for Greenville County,

This conveyance is made subject to any restriction, reservation, zoing ordinances, or easements that may appear of record, or on the premises. This is the same property Conveyed unto Essie Hargaret Harkleroad by deed of William A. Henry dated August 1, 1977 and recorded in Deed Book 1001 at page 627.

TO HAVE AND TO HOLD the said land and premises, including all houses, buildings, improvements and fixtures thereon, with all rights, privileges and appurtenances thereunto belonging or appertaining to Mortgagere, its successors and assigns, in fee simple forever, upon the trusts and for the uses and purposes hereinafter set out, and the Mortgagors covenant with the Mortgagere that Mortgagors are seized of, and have the right to convey the premises in fee simple; that the premises are free and clear of all encumbrances, except a prior mortgage or such encumbrances as are set forth hereinabove; and that Mortgagors will warrant and defend the title to the premises against the lawful claims of all persons such excepts and the event of any default in the performance of any of the obligations of said prior encumbrances, the Mortgagere or assigns may make any payments or perform any acts necessary to relieve said default, and the cost thereof shall be added to the indebtedness hereby secured. Any such default in said prior encumbrances may at the option of the Mortgagere or assigns, be deemed a default under this instrument. Mortgagors herein hereby assign and transfer unto Mortgagee, it successors and assigns, all surplus funds which may come or be in the hands of the holder of any of said prior encumbrances upon foredosure of the same, hereby directing that the same be forthwith paid over to Mortgagee or assigns more the debt hereby secured.

THIS MORTGAGE also secures all future advances in the form of any renewal or refinancing of the aforesaid Promissory Note, which may from time to time be made by the Mortgagers; provided, however, that the making of any such future advances shall be at the sole option and discretion of the Mortgager and upon such terms and conditions as it shall determine.

Mortgagors further covenant and agree:

To pay the indebtedness as provided herein, and to pay when due all taxes, assessments, levies and charges upon or against the property herein described, which are now due or wisch may hereafter become liens on the premises.

(2) To keep the buildings on the premises insured against loss and damage by fire, torzado, windstorm and such other hazards as Mortgagee may require, in amounts satisfactory to Vortgagee, to be made payable to the Mortgagee as its interest may appear, the loss payable clause to be in such form as Mortgagee may require. Mortgagers will pay all premiums to such insurance when due and immediately deliver to the Mortgagee receipts as may be required by Mortgagee, and provide the Mortgagee with the right to inspect such policy or Ocies. In the event Mortgagers fail to obtain such insurance, the Mortgagee may obtain such insurance without prejudice to its right to foreclose hereunder by reason of this default. Mortgagee may make proof of loss if Mortgagors do not do so within 15 days of loss and the Mortgagee may, at its option, apply the proceeds either to reduce the indebtedness secured hereby or to restore or repair the property. All insurance obtained by Mortgagors shall name Mortgagee as an insured and shall be endorsed so that Mortgagee shall receive at least 10 days notice prior to cancellation and so that all proceeds of such insurance shall be paid to Mortgagee as its interest may appear.

(3) To pay to Morigagee any sums expended by Morigagee to cure any default by Morigagors under provisions 1 and 2 above, together with interest thereon at the same rate of interest as provided in the Promissory Note secured hereby, such payment to be secured by this Morigagee, Morigagee, at its option, may require Morigagor to pay to Morigagee one-twelfth (1/12th) of the annual real estate taxes and insurance premiums for the property, such sums to be held in excross by Morigagee and to be used to pay said taxes and premiums for the property.

To keep the premises in good order, repair and condition, reasonable wear and tear excepted, and to allow Morrgagee, at reasonable times, to inspect the premises

Of the pay to Mortgagee, at its option, the unpaid balance of the Promissory Note and any other obligations secured hereby, in the event the premises or any part thereof are con-
