MORTGAGE

THIS MORTGAGE is made this 10th day of December, 1982, between the Mortgagor, Jimmy J. Lindsey, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty Seven Thousand and No/100---(\$27,000.00)---Dollars, which indebtedness is evidenced by Borrower's note dated December 10, 1982, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 10, 1983.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as a portion of Lot #12 on plat of property of Jimmy J. Lindsey, prepared by Carolina Surveying Company on December 10, 1982 and having, according to said plat, metes and bounds as shown thereon. Said plat being recorded in Plat Book 9I at Page 98 on December 10, 1982. This being the same property acquired by the Mortgagor by deed of Joseph H. Bradley and Gaynell H. Bradley of even date to be recorded herewith.
