WHEREAS, EDWIN C. JETER AND CATHY L. JETER

(hereinafter referred to as Mortgagor) is well and truly indebted unto GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight thousand six hundred forty-five and no/100

Dollars (\$ 8,645.00) due and payable in 180 consecutive monthly installments of Fifty-nine and 74/100 (\$59.74) Dollars each, due and payable on the fifteenth day of each month commencing March 15, 1983,

with interest thereon from said date at the rate of three (3%) per centum per annum, to be paid: monthly.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, on the northeast side of Hubert Street and shown on a survey for Gertrude F. Henson dated October 4, 1973 and made by W. N. Willis, Engineers, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Hubert Street, joint front corner with Fred Cooper and running thence N. 26-00 E. 181 feet to an iron pin; thence S. 62-10 E. 54.3 feet to an iron pin; thence S. 26-00 W. 181 feet to an iron pin on the northeast side of Hubert Street; thence with said Street N. 62-10 W. 54.3 feet to an iron pin, the beginning corner.
