TO ALL WHOM THESE PRESENTS MAY CONCERN: KIM CAMPBELL AND ELLEN C. CAMPBELL

Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto BANKERS MORTGAGE CORPORATION, FLORENCE, SOUTH CAROLINA

a corporation organized and existing under the laws of SOUTH CAROLINA, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Thirty-Eight Thousand Four Hundred Fifty and 00/100 Dollars (\$ 38,450.00 ),

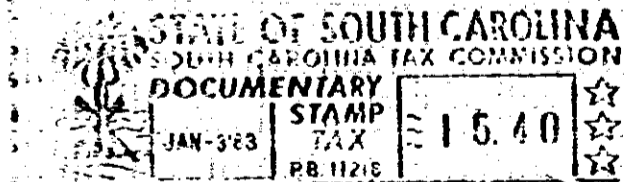
with interest from date at the rate of Twelve per centum ( 12.00 %) per annum until paid, said principal and interest being payable at the office of Bankers Mortgage Corporation in Florence, South Carolina or at such other place as the holder of the note may designate in writing, in monthly installments of Three Hundred Ninety-Five and 65/100 Dollars (\$ 395.65 ), commencing on the first day of February, 19 83, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January 2013

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

ALL that certain piece, parcel or lot of land, together with all improvements thereon, situate, lying and being in Greenville County, State of South Carolina, and being known as 1.10 acres on a plat of property of Willie B. Keller et al recorded in the RMC Office for Greenville County in Deed Book 938 at Page 109, and being more specifically described in plat prepared for Kim Campbell and Ellen C. Campbell by R. B. Bruce, RLS, dated December 8, 1982 and recorded in the aforesaid RMC office in Plat Book 9-K, at Page 81, and having according to the latter plat the following metes and bounds, to-wit:

BEGINNING at an old iron pin in Pittman Road, joint front corner now or formerly with Lillie Pittman and running thence along said road N. 89-30 W., 162 feet to an iron pin; thence continuing along said road N. 65-30 W., 100 feet to a nail and cap; thence continuing along said road N. 0-45 W., 75 feet to an iron pin; thence continuing along said road N. 12-45 E., 50 feet to an iron pin; thence turning and running S. 85-15 E., 387 feet to an iron pin; thence turning and running S. 46-15 W., 196 feet to an iron pin in Pittman Road, the point of beginning.

This being the same property conveyed to the Mortgagors herein by deed of William Lynn Duvall and Susan P. Duvall of even date, to be recorded herewith.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of an interest on the indebtedness evidenced by the said note, at the times and in the manner herein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
