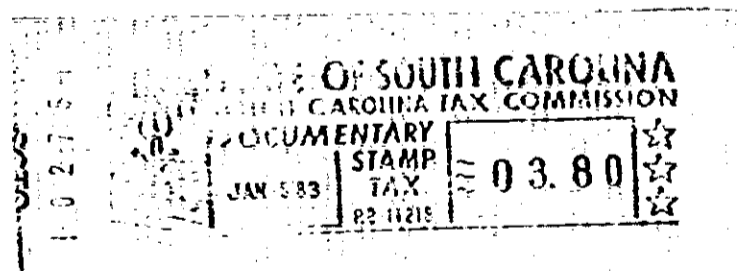

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL that certain piece, parcel or lot of land, situate lying and being in Greenville County, State of South Carolina, known and designated as Lot No. 64, on plat of property of American Bank and Trust Co., made by R.
