WHEREAS, Janet K. Dennings

(hereinafter referred to as Mortgagor) is well and truly indebted unto Southern Bank and Trust Co. P.O. Box 544, Travelers Rest, S.C. 29690

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Sixteen Thousand Nine Hundred Seven and 31/100 Dollars (\$ 16,907.31) due and payable

as provided in Mortgagor's Note of even date (the final maturity of 2-8-90, which is 84 months after the date hereof).

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Lowell Street near the town of Travelers Rest and being shown and designated as Lot 22 on revised map of tracts 58, 59, and 60, Meadowbrook Farms, prepared by C. O. Riddle, R.L.S., as recorded in Plat Book "VV" at page 51, R.M.C. Office for Greenville County, South Carolina, and having, according to said map the following metes and bounds, to-wit:

BEGINNING at a pin, joint front corner of Lots 21 and 22 on the south side of Lowell Street, which pin is 120 feet west of iron pin in the southwest corner of the intersection of Lowell Street with Loraine Drive and thence along the joint line of the said lots S. 12-18 E. 175 feet to an iron pin; thence S. 77-42 W. 130 feet to an iron pin at joint rear corner of Lots 22 and 23; thence N. 12-18 W. 175 feet to an iron pin on the south side of Lowell Street; thence N. 77-42 E. 130 feet along said Lowell Street to an iron pin at the point of beginning.

THE above-described property is conveyed subject to existing easements, rights of way, reservations and restrictions.
