# MORTGAGE

THIS MORTGAGE is made this 17th day of January, 1983, between the Mortgagor, Richard A. and Rebecca C. Waldrep, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty Four Thousand and no/100 (~~\$54,000.00~~) Dollars, which indebtedness is evidenced by Borrower's note dated \_\_\_\_\_, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on Feb. 1, 2013

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

All that piece, parcel and tract of land lying and being situate on the West side of Capers Street in the City of Greenville, State of South Carolina, and being known and designated as Lot No. 84 on a plat of "Crescent Terrace", which said plat is recorded in the Office of the R.M.C. for Greenville County in Plat Book E, Page 137. The lot is specifically described by courses and distances and metes and bounds as follows, to wit:

BEGINNING at joint corners of Lots Nos. 83 and 84 and running thence along joint line of said Lots No. 83 and 84, S. 84-19 W., 175 feet to a corner; thence S. 5-41 E., 70 feet to corner of Lots No. 84 and 85; thence N. 84-19 E. 175 feet to corner on West side of Capers Street; thence along said Capers Street, N. 5-41 W., 70 feet to the beginning corner.

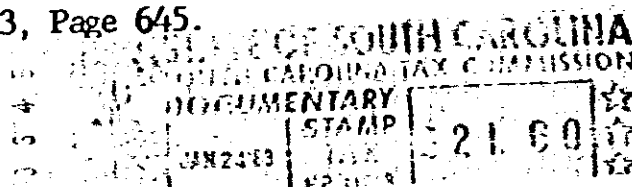
