THIS MORTGAGE is made this 31st <sup>W.L. SAK</sup> day of January, 19 83  
between the Mortgagor William D. Line and Sandra A. Line  
(herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South,  
a corporation organized and existing under the laws of The United States Carolina,  
whose address is P. O. Box 408, Greenville, South Carolina  
(herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of \$38,900.00 Dollars,  
which indebtedness is evidenced by Borrower's Note date January 28, 1983 (herein "Note"),  
providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner  
paid, due and payable on February 192013

For Monthly installments see Schedule A attached <sup>W.L. SAK</sup>  
TO SECURE to Lender: (a) the repayment of the indebtedness evidenced by the Note with interest thereon,  
the payment of all other sums with interest thereon, advanced in accordance herewith to protect the security of  
this Mortgage, and the performance of the covenants and agreements of Borrower herein contained; and (b) the  
repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21  
hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's  
successors and assigns the following described property located in the County of Greenville,  
State of South Carolina:

ALL that certain piece, parcel or lot of land, together with all improvements thereon,  
situate, lying and being in the City of Simpsonville, County of Greenville, State of  
South Carolina and being shown as Lot 525 of Westwood Subdivision, Section V, on plat  
recorded in the RMC Office for Greenville County in Plat Book 4X at Pages 62 and 63,  
and being more specifically shown on plat prepared for William David Line and Sandra  
Ann Line by R. B. Bruce, RLS, dated January 1983 and being recorded in the RMC Office  
for Greenville County in Plat Book 9-4 at Page 12, and having, according to latter  
plat the following metes and bounds, to-wit:
