All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 8-F, being known and designated as Lot No. 2 of the property of Eugene Nalley according to said plat, the following metes and bounds:

Beginning at an iron pin in the center of an unnamed road, said pin being 558.2 feet in a southwesterly direction from an iron pin at the corner of property now or formerly belonging to Fallis Realty Corporation and running thence along the center of said road S. 76-21 W. 307.4 feet to an iron pin; thence S. 86.04 W. 170.9 feet to an iron pin at the joint front corner of lots Nos. 1 and 2; thence along the dividing line of said lots S. 15-05 W. 278.1 feet to an iron pin in the center of the road; thence S. 59-04 E. 137.4 feet to an iron pin at the bend in said road; thence N. 65-56 E. 73.7 feet to an iron pin at another bend in said road; thence N. 17-18 E. 203.8 feet to an iron pin at another bend in said road; thence N. 56-19 E. 344.2 feet to the beginning corner.
