

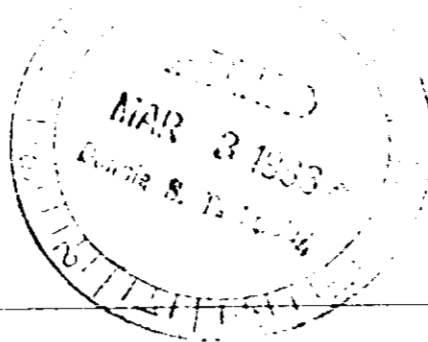

Whereas, I the said John O. Wilson

in and by my certain promissory

note in writing, of even date with

these presents, am well and truly indebted to Southern Bank and Trust

Company of Williamston, South Carolina

in the full and just sum of Three Thousand Six Hundred Seventy-Two and 61/100

(\$3,672.61) Dollars to be paid in Forty-Eighty (48) equal installments in the sum of One Hundred Four and 63/100 (\$104.63) Dollars each, beginning April 8, 1983, and a like installment being due and payable on the 8th day of each and every calendar month thereafter until paid in full.

with interest thereon from date

at the rate of 16.00 per cent, ^{a.p.r.} ~~per annum~~ to be computed and paid monthly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing

for an attorney's fee of a reasonable amount besides all costs and expense of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

consideration of the further sum of Three Dollars, to me the said John O.

Wilson in hand well and truly paid by the said Southern Bank and Trust

Company of Williamston, South Carolina, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Southern Bank and Trust Company of Williamston, South Carolina, its Successors and Assigns forever:

All that piece, parcel or tract of land with all improvements thereon or hereafter constructed thereon situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Tract 2, containing 1.87 acres as shown on plat of Property of Mrs Loraine Wilson made by C.O. Riddle, Engineer, February 25, 1976, and having according to said plat the following courses and distances:

BEGINNING at iron pin on a 50-foot street at the joint front corner of Tract 3 and 2 and running thence N. 42-19 W. 444.3 feet to iron pin; running thence along line now or formerly of Charles M. Forest, Jr., S. 48-10 W. 167.8 feet to iron pin; thence S. 40-32 E. 181 feet to iron pin; running thence S. 48-10 W. 17.7 feet to iron pin;
