TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, MYRTLE J. JONES

(hereinafter referred to as Mortgagor) is well and truly indebted unto GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two thousand two hundred forty and no/100-----

Dollars (\$2,240.00) due and payable

upon demand, which shall be at such time as Myrtle J. Jones becomes deceased or ceases to own or occupy the below described premises. At such time the principal amount shall be due in full with no interest thereon.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

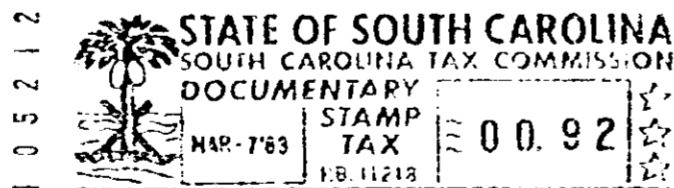
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville just outside the Town of Greer and having the following metes and bounds, to-wit:

BEGINNING at a stake on the south side of James Street on corner of lot #8 and runs thence with line of lots #7 and #8 S. 6-30 W. 221.5 feet to a stake on an alley; thence N. 76-30 W. 57.4 feet to a stake corner of lot #6; thence with line of lot #6 N. 6-30 E. 218 feet to a stake on south side of James Street; thence with said street S. 75 E. 60 feet to the beginning corner, and designated as lot #7 as shown by a plat of land known as "Cannon Park" prepared by H. G. Bailey, Surveyor, November, 1919, which plat is referred to as part description of said premises.

DERIVATION: This being the same property conveyed to the Mortgagor herein by the will of her deceased husband, R. B. Jones, for her life, with the right to sell, as shown in the Probate Court for Greenville County in Apt. 609 at File 49.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
