THIS MORTGAGE is made this 4th day of March, 19 83
between the Mortgagor James A. Boggs and Cindy V. Boggs
(herein "Borrower"), and the Mortgagee, American Federal S&L Association,
a corporation organized and existing under the laws of South Carolina,
whose address is 101 East Coffee Street, Greenville, South Carolina 29602
(herein "Lender").

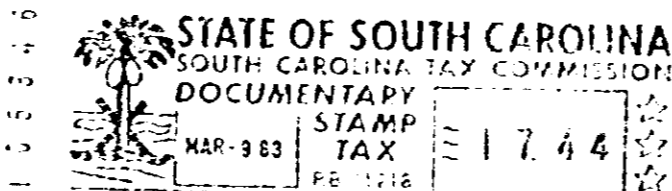
WHEREAS, Borrower is indebted to Lender in the principal sum of 43,600.00 Dollars,
which indebtedness is evidenced by Borrower's Note date March 4, 1983 (herein "Note"),
providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner
paid, due and payable on April 1, 2013

TO SECURE to Lender: (a) the repayment of the indebtedness evidenced by the Note with interest thereon,
the payment of all other sums with interest thereon, advanced in accordance herewith to protect the security of
this Mortgage, and the performance of the covenants and agreements of Borrower herein contained; and (b) the
repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21
hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's
successors and assigns the following described property located in the County of GREENVILLE,
State of South Carolina:

ALL that piece, parcel or lot of land in Austin Township, Greenville
County, State of South Carolina, being known and designated as Lot No. 9
of Forest Trail, a subdivision as shown on plat of survey prepared by
Freeland & Associates on April 18, 1979, and recorded in the RMC Office
for Greenville County in Plat Book 7-X, at Page 59, and more recent
survey entitled "Property of James A. Boggs and Cindy V. Boggs", dated
March 2, 1983, as prepared by Freeland & Associates, and recorded in the
RMC Office for Greenville County in Plat Book 9-0 at Page 8; and
reference is made to said plat for a more particular metes and bounds
description.
