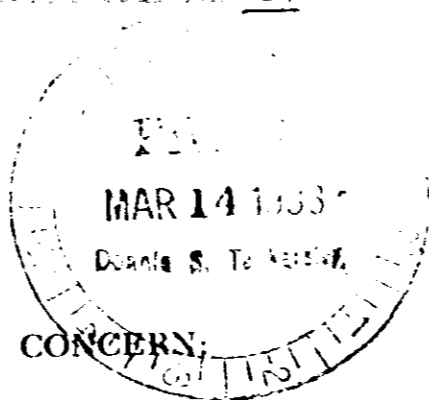

the following described real estate, situated in the County of ~~XXXXXX~~ and State of South Carolina, and more particularly described as follows, to-wit: Greenville

All that lot of land in the County of Greenville, State of South Carolina, being known and designated as Lot No. 61 as shown on Plat of Extension of Brook Forest, recorded in Plat Book QQ, page 17 of the RMC Office for Greenville County, S.C., and having according to said plat the following metes and bounds, to wit:

Beginning at an iron pin on the Southeast side of Altacrest Drive, the joint front corner of Lots 60 & 61, and running thence with the joint line of said lots S. 37-11 E. 140 feet to an iron pin; thence turning N. 52-49 E. 75 feet to an iron pin joint rear corner of Lots 61 & 62; thence with the joint line of said lots N. 37-11 W. 140 feet to an iron pin on the Southeast side of Altacrest Drive: Thence with the Southeast side of Altacrest Drive S. 52-49 W. 75 feet to the point of beginning.
