SEND GREETING:

WHEREAS, we the said G. Henry Watkins and W. Bruce Richmond in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of **Twenty Two Thousand Six Hundred Thirty Four and 61/100 - - (\$ 22,634.61 )** Dollars, with interest from the date hereof at the rate of **fourteen** per cent ( **14** %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

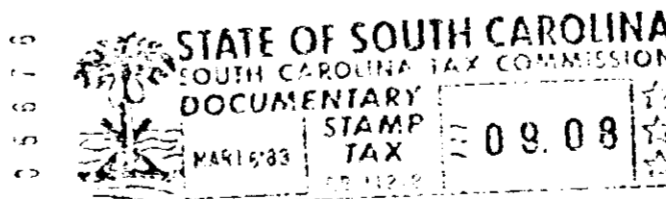
