with interest thereon ~~from~~ at the rate of eleven per centum per annum, to be paid:

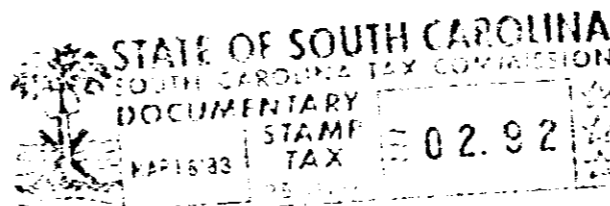

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being in Monaghan Mills Village, and being more particularly described as Lot No. 60, Section 3, as shown on plat entitled "Subdivision for Victor-Monaghan Mills, Greenville, S.C." said plat being recorded in the RMC Office for Greenville County in Plat Book S, pages 179-181, inclusive. According to said plat the within described lot is also known as No. 32 Donaldson Street and fronts thereon 75 feet.
