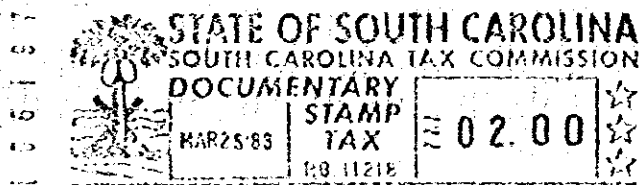
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Longland Drive and being known and designated as Property of William M. Grant as shown on a plat recorded in the RMC Office for Greenville County in Plat Book KKK at Page 153 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Longland Drive which iron pin is 184.5 feet from the southeastern corner of the intersection of Cone Street and Longland Drive and running thence S.67-00 E. 206.9 feet to an iron pin; thence S.25-40 W. 70 feet to an iron pin; thence N.67-00 W. 206.9 feet to an iron pin on the eastern side of Longland Drive; thence along the eastern side of Longland Drive, N.25-40 E. 70 feet to an iron pin, the point of beginning.
