MORTGAGE OF REAL ESTATE

THIS MORTGAGE is made this 4th day of March, 19 83
between the Mortgagor James A. Boggs and Cindy V. Boggs
(herein "Borrower"), and the Mortgagee, American Federal S&L Association,
a corporation organized and existing under the laws of South Carolina,
whose address is 101 East Coffee Street, Greenville, South Carolina 29602
(herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of 43,600.00 Dollars,
which indebtedness is evidenced by Borrower's Note date March 4, 1983 (herein "Note"),
providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner
paid, due and payable on April 1, 2013

State of South Carolina:

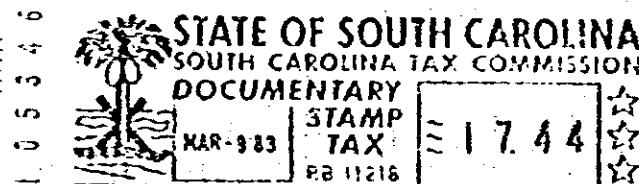
ALL that piece, parcel or lot of land in Austin Township, Greenville
