

Parcel 4:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the Northeast side of Pinckney Street and described as follows:

BEGINNING at a point on said street at Stinespring's corner, which corner is 72.4 feet northwest from the intersection of Pinckney Street and Mulberry Street and running thence along said Stinespring's line N. 54 1/2 E. 100 feet to a stake; thence N. 36 1/2 W. 60 feet to a stake; thence S. 54 1/2 W. 100 feet to Pinckney Street; thence S. 36 1/2 E. 60 feet along Pinckney Street to the beginning corner.

BEGINNING at an iron pin on the northern side of Mulberry Street, said point being 79 feet N. 60-70 E. from the northeastern intersection of Pinckney and Mulberry Streets and running thence with the northern side of Mulberry Street N. 60-70 E. 21 feet to an iron pin; thence N. 33-30 W. 69.6 feet to an iron pin; thence S. 55-56 W. 19.8 feet to an iron pin; thence S. 28-57 E. 68 feet to the point of beginning and being shown as Parcel No. 1 on said plat.

Parcel 6:
