MORTGAGE

THIS MORTGAGE is made this 5th day of April 1983, between the Mortgagor, Richard E. Linville and Phyllis U. Linville (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

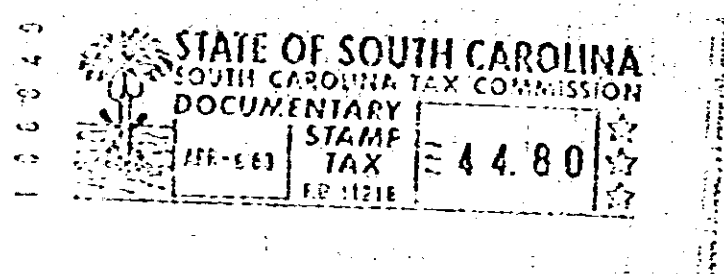
WHEREAS, Borrower is indebted to Lender in the principal sum of One hundred twelve thousand and no/100 (\$112,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated April 5, 1983 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on May 1, 2013;

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville State of South Carolina:

ALL that piece, parcel or lot of land, lying and being situate in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 572, Sugar Creek, Map 4, Section 2, on plat entitled "Property of Richard E. Linville and Phyllis U. Linville" as recorded in Plat Book 9-P at Page 11, in the RMC Office for Greenville County, S.C., and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Ladyslipper Lane, said pin being approximately 672.2 feet from the intersection of Hunting Hill Circle and Ladyslipper Lane, running thence S. 34-40 E. 160.0 feet to an iron pin; thence S. 56-43-46 W. 104.75 feet to an iron pin; thence N. 66-10-17 W. 90.46 feet to an iron pin; thence N. 14-40 E. 150.0 feet to an iron pin; thence N. 80-00 E. 41.73 feet to an iron pin, the point of beginning.
