MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, J. F. GOOD

(hereinafter referred to as Mortgagor) is well and truly indebted unto Hoechst Employees Credit Association

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand One Hundred Eighty-eight Dollars and 96/100

Dollars (\$6,188.96) due and payable

as set forth in the above-referenced note

with interest thereon from at the rate of 13 per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, containing 6.7 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an old stone near a branch, being the Caldwell Corner, and running thence S. 70-30 W., 300 feet to a stake; thence N. 5-20 W., 343 feet to a stake; thence running S. 83-49 E., 1010.7 feet to a point at the road; thence with, or about with, the road S. 16-04 W., 453.3 feet (an old iron pin reference at S. 61-03 E., 9.4 feet); thence running N. 61-03 W., 631.6 feet to the point of beginning.
