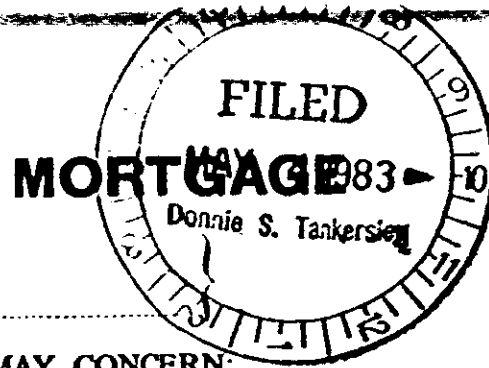

LUCILLE K. HENDRICKS, HIS WIFE (hereinafter referred to as Mortgagor) SEND(S) GREETING:

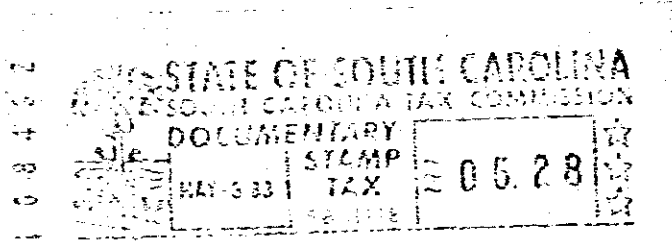

All that tract of land containing .73 acres, more or less, lying on the west side of East Lake Shore Drive in the Lake Lanier Development, Greenville County, South Carolina, Glassy Mountain Township, as more particularly shown and described on plat of survey entitled "Property Conveyance to Volney C. and Zullie W. Cantrell" by H. B. Frankenfield, Jr., Surveyor, dated July 28, 1970, to be recorded in the RMC Office for Greenville County.

This is the same property conveyed by deed of Elizabeth Vehorn Crafton recorded in Deed Book 875, at page 59, RMC Office for Greenville County. Reference is made to said deed and plat in aid of the description. Being that property conveyed to Volney C. Cantrell and Zullie W.
