"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, designated as Lot #58, Section 1, of the Dunean Mills Subdivision, according to a plat recorded in the R.M.C. Office for Greenville County in Plat Book S at Pages 173-177. According to said plat this property is also known as No. 15 Taylor Street and fronts thereon 55 feet.
