 RELEASE FROM LIEN OF MORTGAGE

BEGINNING at an iron pin on the western side of Circle Street, which pin is 125 feet south from the right-of-way of Overbrook car line and running thence with the line of said property N. 75-57 W. 160.5 feet to an iron pin on the south side of said right-of-way; thence with line of Tract No. 4 of Overbrook property S. 7 W. 120 feet, more or less, to the corner of property conveyed to Mamie Smith by deed recorded in Deed Book 269, Page 118; thence with the line of said property S. 75-57 E. 136 feet, more or less, to an iron pin on Circle Street; thence with Circle Street N. 18-45 E. 120 feet, more or less, to the point of beginning; being the same property conveyed to the Mortgagors by deed of Bankers Trust of South Carolina, N.A., as Successor Trustee, recorded in the RMC Office for Greenville County, S.C., in Deeds Book 1071, Page 49, on December 30, 1977.

The above-described property is also shown on a more recent plat entitled "Property of H. Samuel Stilwell" recorded in the RMC Office for Greenville County, S.C., in Plats Book 9-S at Page 56.

In all other respects, the lien of said mortgage is in full force and effect, and remains unchanged.
