Words Used In This Document

- (A) **Mortgage**—This document, which is dated May 11, 1983, will be called the "Mortgage".
- (B) **Mortgagor**—Charlie E & Gladys S Parker will sometimes be called "Mortgagor" and sometimes simply "I", "Me", "my", "mine", "myself", and "us" refer to the Mortgagor.
- (C) **Lender**—The South Carolina National Bank will be called "Lender" and sometimes simply "you". "Your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.

- (D) **Note**—The note, note agreement, or loan agreement signed by Charles E. Parker & Gladys S. Parker and dated May 11, 1983 will be called the "Note". The Note shows that I have promised to pay Lender

which I have promised to pay in full by May 5, 1985

If this box is checked, finance charges or interest under the Note will be deferred, accrued, or capitalized.

- (E) **Property**—The property that is described below in the section entitled "Description Of The Property" will be called the "Property".

My Transfer To You Of Rights In The Property

On this date, because you loaned me the money for which I gave you the Note, I mortgage, grant and convey the Property to you, your successors and assigns, subject to the terms of this Mortgage. This means that by signing this Mortgage, I am giving you those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving you these rights to protect you from possible losses that might result if I fail to:

- (A) Pay all the amounts that I owe you as stated in the Note and any future advances made under Paragraph 17 of this Mortgage.
- (B) Pay, with interest or finance charges, any amounts that you spend under this Mortgage to protect the value of the Property and your rights in the Property.
- (C) Keep all of my other promises and agreements under the Note and/or this Mortgage.

This Mortgage secures any renewals, extensions, and/or modifications of the Note.

Description Of The Property

- (A) The Property which I mortgage, grant, and convey to you, your successors and assigns, is located in Greenville County and has the following legal description:

ALL that lot of land in Greenville County, S.C., being on the southwestern side of Von Hollen Drive (formerly King Street), being shown as Lot 9 on plat of Ethel Y. Perry Estate recorded in the RMC Office for Greenville County in Plat Book S, at Page 49 and also shown on plat of property of C.K. Griffin dated October 1952, prepared By R.W. Dalton, Engineer, recorded in Plat Book CC at Page 48 and having such metes and bounds, as shown thereon. This conveyance is subject to all restrictions, set-back lines, roadways, zoning ordinances, easements and rights-of-way, if any, affecting the above described property. This is the same property conveyed to the grantor herein by deed of Jerry Chapman and Mary Frances Chapman, dated January 27, 1978, and recorded in the RMC Office for Greenville County, S.C. in Deed Book 1972 at Page 768, on January 30, 1978. -235-167-1-41
The grantees herein assume and agree to pay the balance due on that certain mortgage given by William Edwin Lancaster to NCNB Mortgage South, Inc. in the original principal sum of \$21,500.00, dated January 27, 1978, and recorded in the RMC Office for Greenville County, S.C. in Mortgage Book 1422, at Page 67, the principal balance due on this mortgage being \$21,322.98.

- (B) All buildings and other improvements that are located on the property described in paragraph (A) of this section;
- (C) All rights in other property I have as owner of the property described in paragraph (A) of this section. These rights are known as "easements, rights and appurtenances attached to the property";
- (D) All rents or royalties from the property described in paragraph (A) of this section;
- (E) All mineral, oil and gas rights and profits, water, water rights and water stock that are part of the property described in paragraph (A) of this section;
