with interest thereon from date at the rate of 15 per centum per annum, said principal and interest to be repaid:

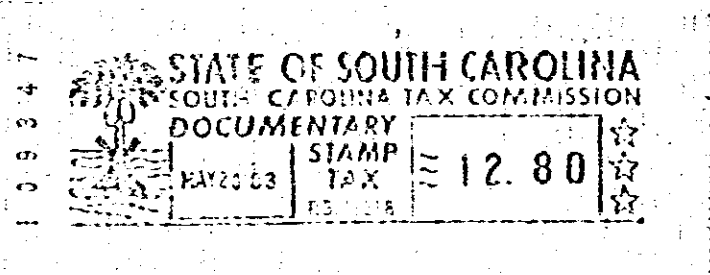
