THIS MORTGAGE is made this 26th day of May, 19 83
between the Mortgagor Roger G. Gaines and Linda W. Gaines
(herein "Borrower"), and the Mortgagee, Alliance Mortgage Company,
a corporation organized and existing under the laws of the State of Florida,
whose address is Post Office Box 2259, Jacksonville, Florida 32232
(herein "Lender").
