(herein "Lender").

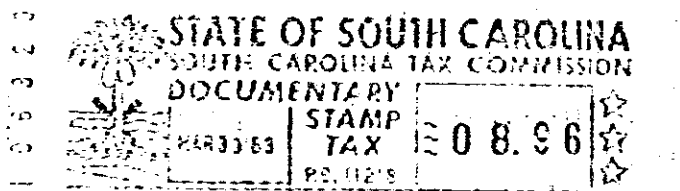
WHEREAS, Borrower is indebted to Lender in the principal sum of \$ 22,325.00 Dollars,
