THIS MORTGAGE is made this 10th day of June 1983, between the Mortgagor, FREDERICK H. WHEELER AND JANICE S. WHEELER, HUSBAND & WIFE (herein "Borrower"), and the Mortgagee, NORWEST MORTGAGE, INC. ITS SUCCESSORS AND ASSIGNS, F/K/A BANCO MORTGAGE COMPANY, a corporation organized and existing under the laws of THE STATE OF IOWA, whose address is P.O. BOX 780, WATERLOO, IOWA 50704 (herein "Lender").

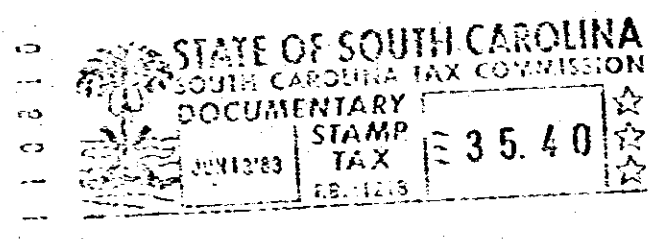

ALL THAT CERTAIN PIECE, PARCEL OR LOT OF LAND WITH THE BUILDINGS AND IMPROVEMENTS THEREON, LYING AND BEING ON THE EASTERLY SIDE OF SWEETWATER ROAD, NEAR THE CITY OF GREENVILLE, SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS LOT NO. 466 ON PLAT ENTITLED "MAP TWO, SECTION TWO, SUGAR CREEK" AS RECORDED IN THE RMC OFFICE FOR GREENVILLE COUNTY, S.C., IN PLAT BOOK 7-X AT PAGE 19. REFERENCE TO SAID PLAT IS HEREBY CRAVED FOR A MORE COMPLETE DESCRIPTION.
