**MORTGAGE** *f. Hopkins*

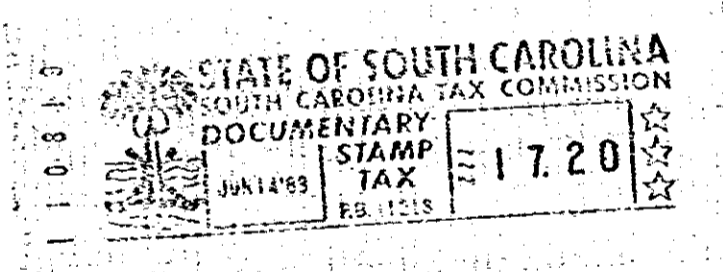
THIS MORTGAGE is made this 10th day of June, 1983, between the Mortgagor, Harold M. Edwards and Harriette J. Edwards, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

ALL that piece, parcel or lot of land, situate, lying and being in the Town of Mauldin, County of Greenville, State of South Carolina, being known and designated as Lot No. 179 on Plat of Forrester Woods, Section IV, recorded in the RMC Office for Greenville County, S.C. in Plat Book 4R at Page 68.

This being the same property conveyed to the mortgagors by deed of Samuel J. Price III and Ann H. Price of even date to be recorded herewith.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
