MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty-eight thousand & no/100 Dollars (\$ 28,000.00) due and payable

with interest thereon from date at the rate of 8 per centum per annum, to be paid: on demand

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lots 3 and 4 on plat of Terra Pine Estates, made by Piedmont Engineering Service, December 1958, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Terramont Circle at joint front corner of Lots 2 and 3 and running thence along the line of Lot 2, S. 54-43 W. 271.3 feet to an iron pin; thence N. 35-02 W. 240.3 feet to an iron pin; thence N. 35-20 W. 129.3 feet to an iron pin; thence along the line of Lot 5, N. 50-08 E. 217 feet to an iron pin on the Southwest side of Terramont Circle, S. 43-23 E. 219.7 feet to an iron pin; thence continuing along Terramont Circle, S. 42-25 E. 170 feet to the beginning corner.

This being the same property conveyed to the mortgagors by deed of Milton Lite, et al dated January 2, 1959 and recorded in the RMC Office for Greenville County in Deed Book 614 at page 83.
